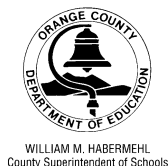
*Criteria*

- ❖ You must be a former student of the nominee.
- ❖ Follow criteria on the attached form.
- ❖ Nominee can be a full-time or part-time faculty member.



*Guidelines*

- ❖ Attached form must be printed out on one two-sided sheet of paper, and submitted with a hard copy signature to SC260. No online nominations will be accepted.
- ❖ Use the attached sheet and provide specific examples of how the nominee meets the criteria as outlined.
- ❖ Use only the attached form and no attachments.
- ❖ We encourage you to use the full space provided so your nominee has every advantage to become Teacher of the Year 2010.



## Orange County Teachers of the Year 2010 Community College Preliminary Nomination Form

The Orange County Superintendent of Schools is pleased to announce the **Dr. James Hines Orange County Teachers of the Year Foundation Awards Program**. This program bestows upon outstanding Orange County classroom teachers substantial monetary benefits, up to \$15,000 for each of the five finalists, one of whom will be a community college teacher.

Since K-12 schools already have a selection procedure in place, this nomination form applies only to community college teachers.

**Eligible to be nominated** is any full-time or part-time community college teacher presently employed in the Orange County school system, whose efforts have inspired and enabled students to improve in their lives in ways specifically attributable to that teacher.

**Nominators are** limited to former students whose perspective allows them to assess the benefits conferred by the nominated teacher and to teachers, counselors and administrators who are in a position to evaluate the classroom effectiveness of that teacher.

**The only acceptable nomination form is the one on the reverse of this page.** No supplementary material, such as pictures, clippings, etc., should be included at this time.

**Criteria defining Teachers of the Year** will be based principally on interactions between student and teacher that have had a lasting beneficial effect upon the later success and happiness of that student. More specific criteria, suggested by students and teachers themselves, are available upon request from the Associated Student Government office.

**Nomination forms will be reviewed by three different committees.** The first paper screening will be done by a committee designated by the Associated Student Government of each college. The most persuasive nominations will be forwarded to a committee consisting of the Deans of the nominee's division, and representatives from the Academic Senate and the Associated Student Government of each college, which group may interview nominees and nominators, and will ultimately submit the name and resume of one candidate to the final committee, consisting of members of the Foundation.

**Nomination forms should be submitted to the ASG office of each college** or deposited in boxes clearly marked **Nominations for Teachers of the Year** and placed in various locations on campus by ASG officials.

**Contact your ASG office for the deadline in submitting the nomination forms** (see reverse side for nomination form).
