# Item 6: Board Policy Review Process (BP 5505: Grade Grievance Policy)

Discussion: President Gabriella walked the Representative Council through the revised draft Grade Grievance Policy. A number of recommendations made from the floor at the 28 October 2006 Representative Council meeting were incorporated into the document. Further revisions were suggested from the floor: (1) offer an option to extend deadlines by mutual agreement of the parties; (2) whether IV A and B should remain separate or be collapsed was left undecided—but the debate leaned toward leaving them separate; (3) IV. A. timeframe should be 45 days; (4) IV.B. add that students should be allowed to withdraw the grievance at any time by submitting a grievance withdrawal form; (5) IV.C. add that the representative appointed by ASIVC should be student from the student body (6) IV. C. 3. Bullet 5, the word "written" should be added; (7) IV. D. 3. add language that allows parties to change their exhibits and witnesses after "discovery"; (8) IV.C.5. change the word "request" to "inform" or "notify" and change the time frame to 10-15 days. President Gabriella announced that she will send the policy to the entire college for review and that the policy will be re-agendized on the 28 November 2006 Representative Council meeting.
