F. EXECUTIVE REPORTS

Senate President: Kathy Schmeidler: The list of faculty hires has been approved through the Board. We are assured funding for 6 positions, but there is possible funding for 10 to 12 positions. The list is posted; Hiring. All documentation from the ASCCC Plenary is posted. Our resolution failed. The arguments against it were that it did not cite any study, and they are sick of talking about SLOs. However, some people from Plenary encouraged us to bring it back for the spring. There was an email vote, 22+ in favor, to write a letter on our behalf in support of the Chancellor's position concerning not using ACCJC as the community college's accrediting body.

Vice-President: Bob Urell: <u>Budget</u> and <u>Registration</u>

The budget is affected by the flat enrollment. We need to reach our target of 2% growth. If enrollment targets are not met, it could result in a possible budget reduction of \$1 million. There are a number of plans to try to increase enrollments including: Freshman Advantage; The Freshman Advantage 2.0 plan can be found here, Freshman Advantage. Please view and email questions asenate@ivc.edu. There is a proposal to change starting dates, in an effort to match other colleges. There is a change the philosophy of filling classes; Any sections that fill to 80% will be able to open an additional sections. There is a proposal to install portable classrooms that would increase the number of available classrooms. Also, building a weekend college is a possibility. College Outreach is seeking more faculty members willing to go to high schools to promote their programs. Please contact Ann Akers or Mikiko Kumasaka for information. The new enrollment management team is looking in to various ways to build enrollments. Also, the international student enrollments decreased and the enrollment management team is investigating the cause.
