H. New Business

Item 13 California College Promise Innovation Grant

Discussion: Kathy Schmeidler –The Promise Program is designed to improve college attendance by students who traditionally have not attended college full time for example first gen students, foster youth, and other local communities. This includes outreach programs and support for students who enroll in full time schedule. Our fast Fridays, Preview Day, Laser Week, and other programs form the platform on which a more cohesive Promise Program will be built. Such students often have difficulty going to school full time, so providing books and supplementing other expenses, effective counseling and mentoring, and other initiatives will increase their likelihood for success.

The Interim Chancellor has directed that IVC and SC will apply for the grant together. It is our expectation that we will split the 1.5 million dollar grant equally.

Traci Fahimi – The intention is that this will be a more integrated process for many things that we are already doing, and the grant will enable us to scale it up and start earlier. We hope to manage a more coordinated process of reaching out to high school at risk students.

Diana Hurlbut – expressed a concern that we will have to set our entire course schedule for an entire year,

there may be problems for CTE courses that need to be changed/added regularly.

Kathy Schmeidler – even if we have registration for an entire doesn't lock us into it. We can still make changes and students can still register each semester.

Traci Fahimi– A benefit is that students can plan ahead and schools mostly map out their schedule ahead of time anyway. It doesn't lock in courses or faculty.

The deadline is Feb. 3rd to apply for the grant. The grant was introduced in December.

Kathy Schmeidler will send out information to all senators. Students in this program should be able to register for an entire year. The grant document will be online. Schools will vote via email. The deadline to vote is Jan. 26, 2017.
