7. EXECUTIVE REPORTS

- A. Senate President: June McLaughlin
 - There's a new law regarding colleges and universities encouraging students to vote
 - Reminder that faculty are limited in what they can say politically on campus, check with HR
 - Student Trustee Ethan Manafi suggested forgiveness of missing class and not giving exams on election day (Tuesday, November 3) because mail-in ballots may not be secure and lines for voting may be long

Academic Senate

- B. Senate Vice President: Jefferey Kaufmann
 - IEC program reviews: postpone '19-'20 program reviews, so more time to get it done
 - IEC recommends getting '20-'21 program review draft documents submitted to deans by December
 - New end-of-academic-year committee reports (discuss accomplishments, goals, etc.)
 - Campus still under construction electronic access complete for Liberal Arts and Library; Life Sciences in process; A200, B100 and SSC will be done by September this year
 - BDRPC asked for cost-benefit analysis, IVC ended up with \$9.5 million surplus due to COVID-19, rolled into next year's budget; Davit Khachatryan will do an analysis of expenses, income, and revenue for all of next year
 - BPARC AR written by district IT about cloud storage, pointed out most every faculty violates it, new small group put together to rework the AR

 - Title IX prohibits discrimination based on sex/gender
 - Marco Caamal assisting
 - Student/Faculty/Staff training available

Academic Senate

- Recent changes under the law to be federally compliant, the district had to release an interim policy (here's a flow chart that explains the process)
- Changes that went into effect August 14:
 - Narrow definition of sexual harassment
 - Now applies to students and employees (HR)
 - Major procedural changes
 - * Jurisdictional limits
 - * Hearing process
 - * Cross-examination must be conducted by the party's advisor
 - * Right to appeal offered to both parties

- B. Board policies and administrative regulations
 - i. BP 6140 Campus Speakers
 - For last year or so, BPARC and Chancellor's Council have been having discussions about this BP; originally BPARC wanted to delete it since the Board of Trustees already sees all speaker requests, Board rejected
 - Board kept insisting on having influence/oversight of all speakers
 - In the last month, the Board rejected BPARC changes, made their own changes, and attempted to pass them without sending the new changes back to BPARC
 - President McLaughlin wants to have a special vote to object to this BP, be in alignment with Saddleback on this, and have a resolution with a strongly worded objection to the Board's actions
 - The ed code referenced in this BP is about freedom of expression of students
 - There is no matching CCLC BP for this type of Board Policy
 - ii. BP/AR 5520 (will be 3200) Accreditation
 - Dan Walsh from Saddleback objects to District's involvement in accreditation process
 - Proposed revisions would eliminate references to District and replace with College presidents and Academic Senates, District will be informed but not included in process
 - Need to figure out if/how this aligns with standard III (HR, physical plant, and technology services)
 - iii. BP/AR 2120 (will be 3250) Institutional Planning
 - BPARC did first reading, no movement because Saddleback Senate was still looking at it
- C. IVC Mission Statement
 - Added "Because" to beginning of first sentence of proposed mission statement and combined with the second sentence
 - New proposed mission statement: "Because student equity, inclusion, access, and success are central to Irvine Valley College's identity, we offer clear and guided pathways to transfer opportunities, certificates, associate degrees, employment, and further education to a diverse and dynamic local and global community. IVC fosters economic and workforce development through strategic partnerships with business, government, and educational networks."
 - Will be voted on at next Senate meeting
