- Senate President (Daniel de Roulet)
 - Redesign of the faculty CAFÉ asking for comments
 - Tim Van Norman's office is there, Senate office will be relocated
 - 6 sound-proof booths for recording classes (not hold live Zooms)
 - First step to address online classes and IVC providing a suitable location for instructors to record and/or hold live Zoom meetings
 - Possible next step includes using smaller classrooms for Zoom-only
 - Vaccination incentives have gone out. If you got vaccinated and did not get \$1,000 in your Nov 30 pay, check Workday and/or call HR.
- Senate Vice President of Equity (Rebecca Beck)
 - Funding still available for equity driven projects (use normal Professional Development process)
 - Enacting Educational Equity Learning Community will be held in the spring.
 Stipends will be available for attending. Email will be sent with details
 - o Critical Race Theory discussion during Flex Week Jan 12, 3-4:30pm, hybrid
 - DEI Statement and IVC Mission Statement
 - Updated statements that focus on the diversity of our college and community. Final statements will be presented soon.
- Senate Vice President (RJ Dolbin)
 - BDRPC CAFÉ conversion could be added to the Library's existing plan for electrical updates. Also, there was a comment on the length of time for the approval process for resource requests...the timeline could be compressed
 - IEC Vision Statement approved by College Council, next to the Board. IVC Program Review process includes annual updates, and we aren't doing them.
 An online form is being developed to make this easier.
 - BPARC Proposed updates to the BP and AR for the Chancellor's hiring process includes changes that need to be addressed
 - The Board can choose anyone to be the Board Designee. Anyone?
 - All applications that meet min quals are forwarded to the Board, why?
 - There is an increase in the Search Committee from 13 to 19 but the proportion of faculty has dropped, why?
 - FYI: This AR has been signed on Dec 2 (AR 2431)
 - For the Chancellor's evaluation, faculty have been moved out of the mandatory consultation group to the recommended group, why?

- Ethnic Studies update to transfer requirements. The Cultural Diversity section will be replaced with an Ethnic Studies section that includes 4 classes
- Curriculum Committee approved a General Education Ethnic Studies Philosophy:
 - Ethnic Studies encompasses the interdisciplinary study of race, ethnicity, and racial formation in the United States. Ethnic Studies courses focus on a variety of themes including racialization, settler colonialism, empire, and intersectionality as they are experienced by African Americans, Native Americans, Asian Americans, and Latina/Latino Americans. Ethnic Studies courses center the experiences of these groups with an emphasis on agency, resistance, liberation struggles, and decolonization movements.

- This is a website/tool that allows students to take a class at another college without
 having to go through the application process again. This reduces friction for students
 looking to take a class that isn't offered, doesn't fit their schedule, was cancelled, or full
 at their home college. This helps students complete community college faster and gives
 them flexibility they might not have at their home school.
- 40% of community college students in CA take classes at more than one college already, this makes that process easier, removing barriers.
- Colleges can join as a 'home' college (our students can take classes on the course exchange) and/or a 'teaching' college (other students can take classes with us)
- Data on our students is available and can be used to offer courses that might fit what they are looking for.
- No college that has joined has seen a net decline in enrollments. UC and CSU students are starting to use the exchange for undergraduate transfer courses as well.
- 75 colleges in the CVC consortium: 65 home colleges and 10 teaching colleges
- Home college implementation is fairly easy, becoming a teaching college is more extensive
- State Chancellor's Office has indicated that this might become mandatory to assist students in completing their courses in 2 years.
- There will be a Flex Week presentation for more information.
