- Recent State Legislation
 - AB 928 UCs and CSUs must have the same general education transfer requirements
 - AB 1111 All CA Community Colleges must adopt a common course numbering system for all general education transfer courses
- Updating IVC's general education philosophy as well as removing cultural diversity, which is a broad range of classes, and replacing it with specific ethnic studies courses (this is anticipation of other state legislation)

 - Faculty Association President Elect (Melanie Haeri)
 - New contract details Student evaluations will become part of faculty evaluations – the specifics are still being negotiated and include revised questions (more meaningful) and that only student evaluations during the time the faculty being evaluated will be included
 - Classified Senate President (Desiree Ortiz)
 - Completion teams are looking for panelists for the <u>First-Gen College Studen</u>t celebrations. The panel will be held on Wed, Nov 10 and we need IVC alums and students who were first-gen college students as well as any faculty/staff who were first-gen grads.

 - Continuing discussions about limiting the time students (possibly unvaccinated) spend at Student Services, what vaccines will be accepted from international students (probably and WHO approved vaccinee), and adding additional online courses so students have an option.

F. OLD BUSINESS

A. Discussion and feedback on the vaccine mandate

- DeAngelo Hunter (ASIVC) students have trepidation about coming back to a classroom. Students also want to make sure that whichever modality they choose, the experience is equivalent, and technology needs to facilitate this.
- Eric Garcia (Guidance and Counseling) Concerned that students aren't being told that there is an alternative to a vaccine as part of the mandate; they can get tested weekly.
- Rebecca Beck Since the mandate won't be approved by the Board until Dec, the
 specifics of it will not be communicated to students until after they register for spring
 classes. There could be a big, late shift in enrollments when this communication is
 finalized (late Dec, early Jan). How will this be dealt with by deans and the VPI with
 lower enrolled courses.
