Standing Items

A. SENATE CABINET REPORTS:

- Senate President (Rebecca Beck)
 - o President's Council-Debrief
 - Yesterday, had a meeting with President Hernandez, Faculty Association President Robert Melendez, the Vice Presidents, Chief Kennedy, and Lt. Romero to do a debrief on the events that unfolded on February 5 regarding the IT security incident.
 - IT from both campuses have installed new safety protocols including the multi factor authentication (MFA). Please encourage students to sign up as soon as possible. Every student has to have the MFA set-up by March 26.
 - Students have been sent an email that walks them through the MFA process. As of last week, only 700+ students have completed the MFA set-up.
 - Canvas has an announcement at the top of each student's portal that
 encourages students to sign up for the MFA. You are welcome to use this
 announcement to send to students.
 - Carrie Goulding asked about the protocol moving forward if a campus employee receives a threat in the future?
 - It is recommended that you contact your area dean right away and submit a CARE report. Also, IT has developed a system and processes where they can completely shut down a student's Canvas shell for a period of time while an investigation ensues.



- Board Meeting
 - Student Equity Plans from both colleges were presented to the Board.
 - During the meeting, Chancellor Barnes reaffirmed the district's commitment to DEIA related work.
 - If ICE comes to your classroom, please refer to the flyer for the correct protocols - <u>Attachment</u>
- o 2025 Equity Planning-Workshop
 - 11 IVC representatives went to Long Beach City College to attend the workshop, "Navigating Student Equity Work in CA"- <u>Attachment</u>
 - California law (Ed code 78220) mandates that the California community colleges serve all student populations.
- o DEIA Day (April 4)
 - Watch out for emails to sign up. This year's theme is focused on accessibility.
 - On March 26, the campus will be showing the documentary "Crip Camp" (sponsored by The Hub).
- Senate Vice President (RJ Dolbin)
 - o Board Policy and Administrative Regulation Council (BPARC)
 - Two BPs/ARs were pulled (5140 DSPS and 5070 attendance). For attendance, discussions are ongoing on whether regular attendance can be included as a part of a student's grade.
 - Recommendation from faculty is to leave AR-5070 as is for now and investigate revisions (if needed) in the future.
 - o District Resource Allocation Council (DRAC)
 - No updates
 - o Budget Development and Resource Planning Council (BDRPC)
 - With the switch to Banner, currently looking at the finance side of the house including the program called "dropper."
 - Tomorrow from 9-1030am, there will be a Vision 2030 Climate Action meeting.
 - Currently exploring alternatives to panic buttons. Possibly moving toward a physical card/mobile smart phone panic button option.
 - Because of campus construction, looking at putting more campus signage for pedestrians to use alternative routes.
 - IVC crime log Discussions are ongoing regarding when a campus safety event occurs and when information should be disseminated to the general community.
 - Food services- ISSI is the hired food vendor for the campus. On April 9, they will be operating out of the Patio Cafe. In August, both the Promenade and Laser Cafes will be open.
 - A pilot group of people will be selected to volunteer in exploring the laptop vs. desktop service.
 - o Institutional Effectiveness Committee (IEC)
 - Al Taskforce is looking for volunteers to use 2 different Al platforms and report back to the group on the pros and cons of each. Please email RJ or Tim VanNorman if interested.

- Academic Affairs Chair (Summer Serpas)
 - o Academic Affairs Committee (AAC) updates
 - Great Teachers Seminar opportunity
 - June 8-12 (San Diego) <u>Application</u>
 - Providing 4 scholarships via rollover funds to faculty to attend the Great Teachers seminar. The conference is sponsored by the Faculty Association of California Community Colleges.
 - The brief application is due March 28 and is outside of annual professional development funds. The scholarship pays for the conference, a single occupancy room, mileage, and meals.
 - Chosen faculty are asked to provide a 1-hr professional development session to share what they have learned.
 - o Professional Development (PD) budget updates
 - Will be presenting to the Senate on April 3 on the PD handbook revisions.
 - Also, AAC is reviewing the Senate bylaws.
 - PD budget has been approved for a budget increase to start on July 1, 2025.
 - For FT faculty, over 82K has been encumbered, for PT faculty (conference and travel), 26K has been encumbered, and 30K for PT faculty stipends has been accounted for.
 - Of the 170K budget, over 140K has been fully encumbered.
 - o The Hub updates and events link
 - Tonight, Acting and Appetizers (5-7pm) in SSC-260K is occurring.
 - Next week, lunch and learn will be presented by faculty as a promising practicing guide.
 - March 27 "Race and Technology: The New Jim Crow" chapter club will be taking place on March 27 from 330-5.
 - Book Club ("Anxious Generation") is set for March 28.

- Curriculum Committee Chair (RJ Dolbin)
 - o Non-credit online asynchronous courses
 - Because of the course set-up in Maverick in terms of grading evaluation, classes are not getting credit for apportionment. Currently exploring the details regarding what needs to be in the course outline in order for classes to be offered online and receive apportionment.
 - The three things that need to be addressed are the grading method, open entry/open exit, and inside/outside class hours if the class wants to be offered online.

 - Common Course Numbering
 - The templates for the courses have not been provided by the state Chancellor's Office yet. The set of templates will be coming out next week.
 - Phase 2 courses that are scheduled for fall 2026 implementation include art history, history, English, and economics. All other Phase 2 courses will be pushed back to fall 2027. - <u>Attachment</u>
