- i. Rick would like the curriculum reviewers to focus on the threading aspect of the course outline of record (COR). This will help the committee become familiar with the essentials of reviewing CORs.
- b. "Program" discontinuance process
 - i. There is a document from 2005 but it is outdated and does not address the discontinuance of awards (certificates and degrees).
 - ii. A process to discontinue awards will need to be established.
 - 1. The word "program" is misleading; this should also be clearly defined in this new process.
 - 2. Program discontinuance involves A&R and the Catalog.

VI. Old Business

- a. Update on Curricunet upgrade
 - i. From the last district-wide meeting: Curricunet Meta was paid for about three years ago but was not used due to implementation concerns. Since Meta is paid for and it is the most easiest to implement, the district-wide search group is considering the upgrade.
 - ii. There will be a product demo on October 30th. Other important pieces such as SLOs, program review, and catalog will be examined. The group will also consider other vendors.
- b. Discuss local separation of AA/AS General Education requirements
 - i. Judith: the proposed AS GE pattern will make it easier for students who are in high unit majors to be awarded with a local degree.
 - ii. Traci: it sounds like a proposing a separate STEM GE pattern is an easier decision because it could be specific to students who are in high unit STEM majors. The discussion of which majors could be an AA or AS can be addressed another time.
 - iii. Rick: there is a general consensus that our existing AA/AS requires too many units.
 - 1. We currently have a GE COA for UC and CSU. There is a 50% policy that students have to take at least half of their units at IVC before we can award them. The Registrar is suggesting that we remove the 50% rule from the GE COAs so that we can award students with something as opposed to nothing.
