#### VIII. New Business

- a. Assignments vs MOEs
  - i. Rick: Please review the draft model. The goal is to make Meta easier to use and to make clearer the threading between learning objectives, assignments, and MOEs.
- b. Catalog Description:
  - i. Rick: What should be in a catalog description? The goal is to have instructional text on Meta that explains what needs to be included. Please bring any suggestions.

#### IX. Old Business

- a. AA/AS GE Requirements
  - i. There are courses in our local AA/AS GE requirements that may not belong in their respective categories, or there may be courses that should be included. Please discuss with your schools.
- b. Ethnic Studies Requirement
  - i. Edwin Tiongsin: We know that students of color are not as successful. By removing this requirement, we are taking on an identity-neutral stance. If the college wants to remove the requirement, then we need to have identity-centered curriculum. We should examine the courses that are currently flagged as ethnic studies and qualify if they are truly focused on diversity. IVC should not become a degree mill. If the district's goal is to educate students on culture and diversity, then removing the requirement without a viable replacement is not the answer.
  - ii. Pierre Nguyen: In the scope of increasing completers, the School of Life Sciences voted 6-3 in favor of removing the requirement.
  - iii. Robert: If the goal is to make earning a degree faster, it is problematic to focus on removing only the ethnic studies. All areas should be examined.
  - iv. Carolina: We should look at data to see how many students are not completing due to the ethnic studies requirement.
  - v. Traci: Unit values should be examined as well. It is not fair to keep removing social science courses when there are subjects that have high unit values.
  - vi. Rick: Please communicate this with your schools so that the committee can recommend an action.
- c. Bylaws
  - i. If there is anyone who wants to help draft bylaws, please contact Rick.
- d. Catalog Addendum
  - i. Traci: The Catalog Workgroup is recommending the addendum be called "Catalog Update". Also, it is being discussed that award name changes should be excluded in the catalog update due to technical and

philosophical reasons. The workgroup will continue this discussion and report at a later date.
