- VIII. New Business
 - a. SLO Training Presented by Keith Donovan
 - i. Accreditation standards require that SLOs are on the Course Outline of Record (COR).
 - ii. There are three things the committee should look for during curriculum review:
 - 1. Are there SLOs on the COR?
 - 2. Are the SLOs listed clearly and are they measurable?
 - a. Should begin with the *when*, followed by the *who*, and then add the *what*
 - 3. Are there enough SLOs?
 - a. Best practice suggests 3-8 per course. Accreditors have been known to flag courses with one SLO.
 - b. If the course only has one SLO, return to the initiator
 - iii. Learning Objectives (LOs) vs SLOs
 - 1. LOs are hopes for students, SLOs are what the students should be walking away with
 - b. Title 5 Ethnic Studies
 - i. IVC's AS GE requires one course in the area of ethnic studies. This requirement is not mandated by the state. Removing this requirement will provide students with more course options. A concern in removing this requirement is that it hurts IVC's philosophy of a robust education. Whether to keep or remove this requirement should be discussed.
