- a. Articulation Officer reminded everyone to make sure to share the IGETC and CSU GE submission list, that was emailed to them, to their faculty for review and notify her of any changes. We will be submitting them in December

- a. Spring curriculum meeting schedule
 - i. Open discussion on whether our meetings will remain virtual or transition in-person. The committee agreed that meeting virtually allows for efficient review of curriculum.
 - ii. Motion to meet virtually in the Spring: Ilknur Erbas-White
 - 1. Second: Brandee Idleman
 - 2. Approved unanimously
- b. Process for transfer submission
 - i. Timeline is defined as:
 - 1. Prior to November Meeting: AO will communicate with discipline faculty leads and chairs regarding submissions for transfer.
 - 2. November Meeting: AO will present transfer list to Curriculum Committee. School representatives will forward to their constituents. Any changes to this list will be addressed with faculty and chairs.
 - 3. December: Courses will be submitted to CSU & UC.
 - 4. May: Typically in May, approved or denied transfer courses will be communicated back to faculty. Faculty will confirm receipt of transfer status to AO.
 - ii. Discussion included the importance of collaboration and communication. Consensus was that no motion or vote is needed with the defined timeline

IX. Old Business

- a. AB 928 (one GE pattern) update
 - i. The Assembly voted to create this bill, but it wasn't supported by many groups in CCC system: Academic Senate, union or presidents council. IVC has no action steps at this time, though the new Bill is being discussed at the state level.
- b. ES philosophy update
 - i. Next steps would be to define what courses should be included. This discussion will continue in the larger committee instead of a subcommittee. It was suggested to invite a student rep for input as well.
- c. Clarify school rep vacancies
 - i. Confirmed minutes from last meeting; though a School seats on the Committee may be vacant, curriculum from that School will still be reviewed.
