Irvine Valley College

was established in 1979 as a satellite campus—Saddleback College North—and quickly distinguished itself for its high quality of instruction and small-college atmosphere. In 1985, it was accredited by the Western Association of Schools and Colleges and assumed its current name as a separate institution. In its first year, Irvine Valley College enrolled 2,600 students. Today, with over 13,100 students from California, across the United States and 50 foreign countries, IVC has established a reputation for academic excellence.

The college offers a comprehensive curriculum, from the traditional liberal arts and sciences to the study of advanced technologies. Students may choose from among 59 associate degree majors, including university studies in preparation for transfer, and 35 career and technical certificate programs. The college supports 24 student clubs and organizations for every interest, from the Biology Society to

Phi Theta Kappa. IVC's Emeritus program, one of the fastest-growing segments of the college, offers classes at 21 off-campus sites for older adult students throughout Irvine and the surrounding communities.

As Irvine Valley College continues to grow, the campus has developed an ambitious building and renovation plan to meet students' needs well into the future. The college recently completed a \$5.4 million green-energy retrofit with innovative technologies—including solar power—that will help preserve the environment, conserve energy, and reduce costs while greatly improving service across the campus.

The fine arts program takes center stage with a new \$31 million Performing Arts Center and Theater that will become the cultural and artistic center of the campus when it is completed in 2007. The Department of Athletics hopes to build a multi-use soccer stadium. And over the next five years, Irvine Valley's 100-acre campus will be transformed with the construction of

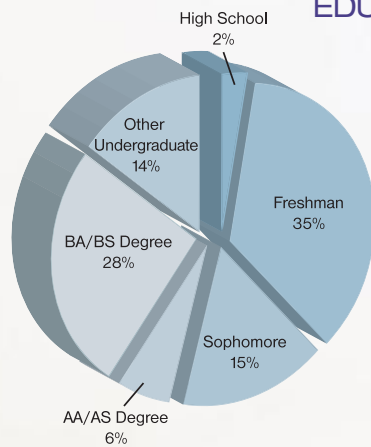
a Business Sciences and Technology Innovation Center in 2008, a new Life Sciences building in 2010, and a Fine Arts building in 2011. When new construction, renovations, modernizations and other site improvements are completed, investments will total over \$143 million.

IVC serves a sophisticated community that includes seven area high schools; the University of California, Irvine; and the Irvine Spectrum, a modern, planned complex with one of the highest concentrations of high technology, manufacturing, business, finance, and retail in California.

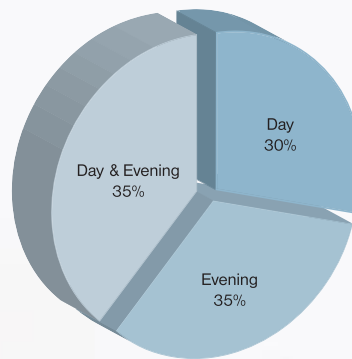

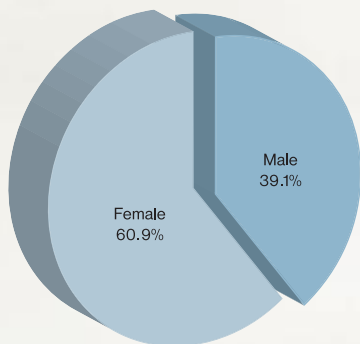
EDUCATION LEVEL



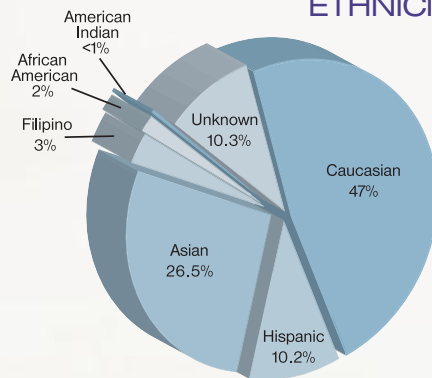
ENROLLMENT PATTERN



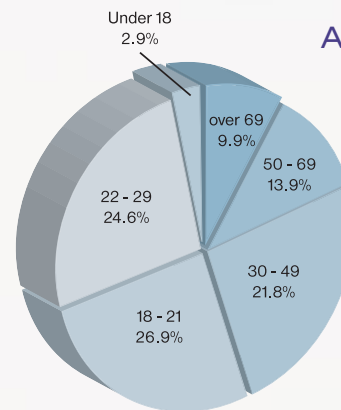
GENDER

Successful Students

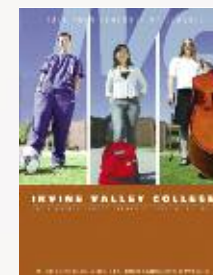

Ronaldo Paolo Panganiban, originally from the Philippines, is a molecular biology major. He plans to transfer to UCLA, Berkeley, Stanford, or Caltech and hopes to conduct drug research or stem cell research. He is an active participant and tutor in the IVC Honors Program.

Marshall Hamachi enjoys drawing and model making. He is retraining at IVC, taking classes in the Design Model Making and Rapid Prototyping program. His plans include transferring to Art Center College of Design and pursuing a career in industrial design.

Full-Time Teacher of the Year

Professor Dorothy Sherling

School of Mathematics, Computer Science and Engineering

Dorothy Sherling has taught at Irvine Valley College since 1994. She was chosen by students as Teacher of the Year for her belief that students can achieve higher academic goals than they could have imagined for themselves, and for making math understandable. In 2003, Sherling became director of the college Honors Program, which offers motivated students the opportunity to undertake academically rigorous coursework in a variety of disciplines. She has a Master of Science and a Ph.D. in mathematics from the University of Houston, and a Bachelor of Science in mathematics from Auburn University. In 1981, Sherling received the Teaching Excellence Award from the University of Houston.

Adjunct math instructor Barry Pearlstein was chosen by students as Part-Time Teacher of the Year for his ability to make a difficult subject easy to understand. Pearlstein has a Master of Science from the University of Southern California, and a Bachelor of Science from the Massachusetts Institute of Technology.

Gifts

Gifts to IVC may be made as unrestricted support or as restricted support for a purpose you designate. Your gift may be spent on current programs or may be placed in an endowment to ensure funding in perpetuity. However you choose to give, you can be assured that your philanthropy will help secure the future of our great institution. Here is a list of the ways you can support IVC and its students.

Endowments and Scholarships

Donors who make gifts to endowments and scholarships are an important part of the college's support system.

Last year, the IVC Foundation awarded nearly \$140,000 to deserving students at the annual Scholarship Awards Ceremony. In total, more than \$224,000 in scholarships was awarded during the 2005 academic year. Such scholarship awards would not have been possible without the outpouring of private support given to Irvine Valley College.

With a minimum donation of \$5,000, an

endowment will be created in your name that will benefit Irvine Valley College in perpetuity. The principal remains intact and only the interest from the original endowment amount is awarded every year.

Gifts of Cash, Check or Credit Card

These are the easiest and most direct ways to give to IVC and are deductible for individuals who itemize their federal tax returns. When making a gift by cash, check or credit card, you can enjoy seeing the immediate results of your generosity to IVC. Your donation can be a one-time gift, or it can be spread over time using pledge payments. Checks should be made payable to the Irvine Valley College Foundation. VISA and MasterCard are accepted.

Gifts of Stock or Real Estate

Gifts of stock or real estate are excellent ways to maximize the value of your donation. In most cases, the full market value is tax deductible, and the capital gains tax that would be paid if the assets were sold is avoided.

Life Income Gifts/Planned Gifts

Planned gifts bring financial benefits to you, your family and the college. Gift annuities, charitable remainder trusts and other vehicles can provide the donor with increased income, a current income tax deduction, and a reduction of capital gains taxes.

Bequests

Donors may wish to ensure their legacy by including IVC in their will or living trust. Gifts by bequest can be made as a specific dollar amount or as a percentage of the residue of the estate.

Matching Gifts

Another method of increasing your gifts to the college is through a corporate matching gift. As a benefit to its employees, many companies "match" charitable donations to certain types of organizations, such as colleges. Foundation Awards Dinner

More than \$31,000 was raised at the 18th Annual Foundation Awards Dinner in 2005, which marked an important milestone—the 20th anniversary of the college.

The first Entrepreneur of the Year Award was presented to Wahoo's Fish Taco founder, Wing Lam.

Four outstanding individuals were honored with the IVC Medal Award:

- Milton and Amelia Madole, parents of IVC Baseball Coach Kent Madole, for their financial and in-kind contributions to the college baseball program.
- Assistant Women's Volleyball Coach Misty May, in recognition of her Olympic gold medal for beach volleyball.

- Dr. Stephen Rochford, in recognition of having built the largest endowment on campus, the Wind Symphony Endowment, which now totals over \$123,000.

- Carol Tagayun, in recognition of her dedication to the IVC Foundation, and AT&T (formerly SBC), for their generous financial support.

Scholarship Awards Ceremonies

Students received 215 scholarships totaling over \$140,000 at the Scholarship Awards Ceremony in May 2005—\$20,000 more than the previous year, thanks to many benefactors. Students received scholarships for excellence in academics, distinguished community service and financial need. In total, more than \$224,000 in scholarships was awarded during the 2005 academic year.

The top two scholar athletes from Irvine Valley College were honored at a special luncheon hosted by the Exchange Club of Irvine. Volleyball player Audrey Sipkovich

(3.9 GPA) and basketball player Manny Maceira (4.0 GPA) each received a \$500 scholarship in recognition of their academic achievement.

Special Events

A special ceremony is held each year to commemorate the lives lost during the 9/11 tragedy in 2001, and to honor the sacrifices that American troops have made to defend our freedom. The guest speaker in 2005 was Angie Kardashian, "Chef Extraordinaire," who sold her restaurant of 22 years, Angie's Cuisine Italiano in Tustin, and moved to New York to cook for firefighters for two years. She was named an honorary firefighter by the New York City Fire Department. During the ceremony, a wreath was placed at the 9/11 Memorial Plaque donated by the Foundation in 2002.

Wahoo's Fish Taco Founder, Wing Lam, was the guest conductor at the Irvine Valley College Wind Symphony Concert at the Irvine Barclay Theatre.

Astounding Inventions

IVC Growing Inventors

After preliminary rounds involving more than 4,000 students from Irvine and Tustin Unified School District, over 350 elementary and middle school students competed in IVC's Astounding Inventions. For 19 years, this annual event encourages students to use their creativity to produce imaginative inventions. The IVC Foundation raised over \$32,000 for the 2006 event from individual and corporate donors, the largest amount raised to date. Nearly \$6,000 in cash and prizes was awarded to first and second place winners who entered the competition. As in past years, a winner was taken by private limousine to NBC Studios in Burbank for "The Tonight Show with Jay Leno."

Faculty and staff were involved in the Math Magic show, Make-A-Quake demonstration, solar observation, the Mad Chemists show, and other exhibits. Also participating were Cal State Long Beach Mobile Science Museum and the Discovery Science Center.

Lasting Legacy

For nearly 20 years

Tom Wall has been an enthusiastic supporter of Irvine Valley College. Since 1983, Wall has been an advocate for the college and student achievement. He served for 12 years as a member of the Foundation Board of Governors and chaired the Foundation for two years. Wall is credited with establishing the Foundation Awards Dinner, the college's premiere annual fundraiser and banquet, for which he has often served as master of ceremonies.

Wall received an honorary Associate in Science degree in administration of justice in recognition of his efforts to promote the mission of the college.





A Campaign for the Arts

Opening in 2007, Irvine Valley College Performing Arts Center

A \$31 million Performing Arts Center is currently under construction. The 53,207 square-foot facility will seat 400 on its main level and opera-house balcony. The center will include a costume shop, scene shop, and dressing rooms. Intended as a compre-

hensive learning environment for theatre and choral and instrumental music, the facility will replace the 1,594 square-foot existing theatre, which seats only 63. Its striking design promises to serve as the defining image of the campus, and an architectural gem for the community.

The IVC Foundation has embarked on a campaign to raise \$2 million to enhance the center.

The State of California and the South

Orange County Community College District are funding initial construction of this beautiful facility. Private investment is critically needed for immediate and future needs of the facility and to support the academic programs in fine arts which now have the space to grow. With community support, the Performing Arts Center at Irvine Valley College will provide a state-of-the-art learning experience for students and a one-of-a-kind audience experience.
