

# F-1 Tax Filing Instructions for International Students

F-1 visa students who were physically present in the US in 2024, regardless of employment in the US, must file taxes.

Students overseas in 2024 do not need to submit any documents.

## If you were in the US in 2024 and were EMPLOYED in the US, follow these instructions:

Students who were employed in the US in 2022 must complete 3 forms: For

Form 1040NR 540NR (Short) Form 8843

If you earned income in 2024 from an on-campus job, OPT employment, or scholarship, you must file both state and federal taxes as required by US law. Payment of and/or refunds of taxes will be based on your total income – as indicated on the W-2 that you should have received from your employer – either IVC or your OPT employer.

**1040NR** is the Federal tax form. This form can be downloaded from the IRS website: <u>www.irs.gov</u>. Enter "1040-NR" in the search box to find the 1040-NR form and instructions.

**Form 8843** is another Federal tax form required of <u>all</u> students. This form can be downloaded from the IRS website: <u>www.irs.gov</u>. Enter "8843" in the search box. <u>You must complete the following sections on Form 8843</u>: address in your country, address in the US, Part I General Information, Part III Students and then sign and date where indicated.

**Form 540NR (Short)** is the California tax form. This form can be downloaded from the State of California Franchise Tax Board website: https://www.ftb.ca.gov/. Click on "Forms" and scroll down to "540NR".

## All forms are due by April 15, 2025:

Mail the 1040NR and Form 8843 to the address provided on the 1040NR form. Mail the 540 NR form to the address provided on the 540 NR form.

#### If you were in the US in 2024, but were NOT EMPLOYED in 2024, follow these instructions:

Students who were NOT employed in 2024, but were present in the US in 2024 must complete 1 form: Form 8843

If you were on the F-1 visa in the US and did <u>not</u> receive any income during the 2024 calendar year, you must file Form 8843. This form can be downloaded from the IRS website: <u>www.irs.gov</u>. Enter "8843" in the search box. <u>You must complete the following sections on Form 8843</u>: address in your country, address in the US, Part I General Information, Part III Students and then sign and date where indicated.

### Form 8843 should be mailed by June 15, 2025:
